

The course, also through the reading in translation of most of the books of the Old Testament, intends to provide – in view of the following phases of the study (exegesis, theology) – the essential information on the following topics: content, literary characteristics, structure and composition of the various books; literary history of the Hebrew Bible; history of Israel and its religion; main theological themes.

The so-called "fourth song of Yhwh's servant" is notable not only for its difficulty but also for the role its interpretations have played in Christian–Jewish relations. The seminar aims to achieve an annotated version of the text.

The stranger in the Hebrew Bible

"... you know the state of mind of the stranger, for you were strangers in the land of Egypt." (Ex 23:9) At various levels (social, normative, religious), the relationship with the stranger/foreigners appears in many pages of the Hebrew Bible. The term "foreigner" is controversial in current public debate today. This course aims to offer a biblical insight, eschewing both easy "actualizations" and underestimation of the discourse.

New Testament exegesis/Selected passages from the letter to the Hebrews**B2,3_4 ECTS/M1,2_6 ECTS****(2 hours per week)**

This letter often remains at the margins of New Testament study, unjustly overshadowed by the great texts that have marked Christian theology. Actually, it is characterized by depth and originality of thought, helping us also to grasp the variety of theologies expressed by early Christianity. In addition to analyzing the main passages of Hebrews, we will also try to give due attention to the way in which the Old Testament is interpreted here: The numerous quotations make this letter a true essay in biblical theology.

Seminar (+ course). New Testament Exegesis/Scriptural references in the Synoptics: comparing styles

M1,2_2 CFU**(1 hours per week)**

One Bible, different uses. The Old Testament is used by the three synoptic gospels in different ways, and the purpose of this seminar is to analyze a few passages in which the characteristics of each evangelist stand out most prominently. With an eye to the Middle Jewish biblical hermeneutic.

The course functions as a prepared and careful reading of selected texts in the various literary genres of the New Testament, with special attention to syntax, vocabulary, and construction of discourse or narrative. The course also functions as an introduction to exegesis.

SECOND SEMESTER

XNTB01

Introduction to New Testament Reading/B1_7 ECTS (5 hours per week)

The Introduction to the New Testament course is structured around three main topics. First, we delve into the study of the world in which Jesus and the apostles were born and worked. We will address the principal writings of this rich historical period, which are inescapable if we are to fully understand the origin of Christianity and its theology. The second topic is the narrative literature of the New Testament: we will examine in depth the history of the formation of the texts, the historical and cultural contexts in which they were produced and handed down, the sources, traditions, forms, editing, the relationship with historical facts, and the significance of the story in its narrative development, with a strong focus on research on the historical Jesus. The third part deals with epistolary literature, focusing on the Pauline corpus. The study will be illustrated by the reading of various New Testament texts.

New Testament Theology/*The Middle Jewish theology of the synoptic gospels* B2,3_3 ECTS/M1,2_5 ECTS (2 hours per week)

What if we try to read the theology of the synoptic gospels not only as Christological reflections internal to the Jesus movement, but as documents in dialogue with first-century Judaism? How are Mark, Matthew, and Luke, in their different backgrounds of origin and theology, influenced by Middle Jewish thought? We will find that these gospels neither derive from Middle Judaism nor mark a path of separation from it, but are an integral part of it, a full expression even where we perceive the existence of a conflict with "the Jews" or the "synagogue."

B3: active participation in the course; study of a textbook on New Testament Theology; final written and oral examination on the textbook and the topic of the monograph course (examination bibliography given in class)

HISTORY OF CHRISTIANITY/Prof. Lothar Vogel

FIRST SEMESTER

XSCB01, XSCB02, XSCB03, XSCB11, XSCB12, XSCB13

Course. *History of Ancient Christianity* /B1,2,3_ 3 ECTS**(2 hours per week)**

The course of lectures, planned for the both academic year, introduces to the history of ancient and medieval church. It wants to offer a general view of the development of Christianity as a historically documented reality and of Christian doctrines. In the winter semester will be treated the first to the seventh centuries (until the 6th Oecumenical Council of Constantinople in 680/81).

Seminar. *The Council of Nicaea (325)*/B 2,3/M 1,2_3 ECTS**(2 hours per week)**

In the proximity of the 1700th anniversary of the council, in which the homoousia of Father and Son was defined as a cornerstone of Christian doctrine, this seminar course intends to explore the historical significance and the history of the effects of this event. By working on the original sources, the history of theology as well as organisational and ecclesiological issues will be considered.

Pro-Seminary

The *Nobla Leiczon*/B1_ 2 ECTS (2 hours per week)

This course aim is to introduce beginners in theological studies to the methodology of historical research by working on a specific source. Furthermore, this course want to encourage a reflection on the significance of church history in Protestant theology. The source to interpret is the *Nobla Leiczon*, of the 16th century's Waldensian Manuscripts. This text allows insights into the theological thinking of the Waldensians before their adhesion to Protestant Reformation.

Lessons are online via platform, thus basic face-to-face, but participants are constantly urged to use the language actively, according to the inductive-contextual method already used in the previous course. The goal is to conclude the study of verb morphology and related syntax, in order to begin in Semester II the anthological reading of Old Testament and New Testament texts on which to practice language skills.

Course of lectures. *History of Medieval Christianity*/B1,2, 3_3 ECTS (2 hours per week)

In the second semester the lectures will introduce to the medieval epoch (7th - 14th centuries). The focus will be concentrated on the Western church (spirituality, church organisation, monasticism, theology, dissenters, confrontation with the surrounding cultures). Besides the Latin sphere, also the history of Greek and Slavic Orthodox Christianity will be object of reflection.

Accreditation: based on required regular participation and a final oral or written examination. Students who also frequent the course of lectures of the winter semester can have a joint accreditation based on an examination about both semesters.

XSCE02, XSCE03, XSCE04, XSCE05, XSCE22, XSCE23, XSCE24, XSCE25

**Seminary course. *The Waldensian movement*/B2,3/M1,2_3 ECTS
(2 hours per week)**

In the context of the 800th anniversary of the religious conversion of Valdo of Lyons, the course aims to contextualise and identify the specifics of Valdo's religious choice and to follow the history of its effects throughout the Middle Ages, up to the encounter with the Hussite Reformation. The work will be based on the reading of sources and the analysis of different interpretative approaches.

FIRST SEMESTER

XSIC01, XSIC02

Introduction to systematic theology/*Fundamental structures of the Christian faith*/ B1,2_3ECTS (2 hours per week)

The lectures will sketch the main lines of the Christian Doctrine, following the Nicene – Constantinopolitan Creed. The course has also the methodological goal to make students familiar with the way of thinking of Protestant Dogmatic Theology.

The lectures will present a little trip in the history of Christian thought in XXth Century, with emphasis on the main authors and periods: Harnack, Barth, Bonhoeffer, Bultmann, Rahner, Tillich, Second Vatican Council and developments in Roman Catholic theology, present debates.

SYSTEMATIC THEOLOGY/ Prof. Fulvio Ferrario

The institutional program will illustrate the announced theological topic, with the help of appropriate manuals. The monographic part will consist of a presentation of the epistemological structure and ecclesial nature of evangelical theology.

Introduction to the History of Philosophy/ *Literature as Philosophy/* B1_ 2 ECTS (2 hours per week)

The lectures aim to offer an introduction to some of the problems of modern Western philosophy through literary texts from the 16th century to the present day.

Accreditation and examination

The examination consists of the presentation of two papers, devoted to literary works examined in the lectures, and an interview of about half an hour based on them.

History of religions. *Non-Christian religions in Italy. History, doctrine, current affairs/* B1,2_3 CFU (2h weekly)

Religious pluralism in Italy is a fact; however, it is not only a recent phenomenon. The presence of Jewish and Islamic communities on Italian territory has a long history. Starting from these two centuries-old presences, the course deals with two other constantly growing religious areas: religions of the Indian subcontinent and those of the Far East (China and Japan). The starting point is religions in their current state; thus, it is a synchronic approach combined with a diachronic one as to the history of each individual faith community.

Accreditation

Written report (8 000-10 000 characters, including spaces), on a topic agreed upon with the lecturer. b) Colloquium of about 30 minutes, divided, in principle, into two topics, one of which is chosen by the candidate or applicant.

**Theology of religions. *From faith to faith (Romans 1:17)* / L3/M1,2_3 CFUs.

The main objective of the course is to identify in the field of Christian theology useful methodological tools for the proper setting of dialogues with other faith communities. An in-depth reflection on the dialectical tension between faith and religion forms the conceptual basis of the reflection. The main topics developed during the lectures compose a useful framework for a theological evaluation of the major world religions. Completing the lectures is the seminar portion (8 hours) of the course devoted to reading Emile Durkheim's essay, for a Definition of Religious Phenomena (the text will be provided by the lecturer).

Accreditation

a) Classroom report (approx. 20 min.) on one of the topics of the seminar part or a written report (10,000–12 000 characters, including spaces), on a topic of the course agreed with the lecturer. b) Colloquium of approx. 30 min., divided, in principle, into two topics, one of which is chosen by the candidate or applicant.

Bioethics Course/ L1,2,3/M1,2_3ECTS

(12 hrs total)

This course offers basic training in Bioethics with emphasis on the Protestant theological perspective on this complex area of study. The articulation of the course includes an introductory module that outlines the historical framework of the subject, beginning with its origins in the research of Protestant theologians, and explores its interdisciplinary character; a part dealing with the main bioethical models and methodology; and a seminar part devoted to the application of ethical-theological reasoning tools to a scientific and biotechnological topic. Readings of texts and documents of different orientations will be offered, so that students can acquire the necessary competence to interpret and analyze a bioethical position by applying correct modes of argumentation.

Course. Catechesis with method: authenticity, attention to learners/B1, 2_3ECTS

(2h/week)

The course has a twofold aim: 1) to develop valuating skills in the field of catechesis and religious education; 2) to be able to translate them into methodologies that take into consideration the psycho-social, cognitive and religious development of all age groups, valorising and reorganising experiences and any previous knowledge in the catechetical field. The following topics will be covered: introduction to historical catechisms, psycho-social and religious development, methodologies suitable for "toddlers' worship", Sunday school, adolescent catechism and adult education and intercultural groups.

In the light of the history and theology of Christian worship through the centuries with attention to the Reformation of the 16th century, the ecumenical and liturgical movement of the 20th century, and the liturgical reforms of the Second Vatican Council in the Catholic Church, it is proposed to examine Christian worship in the globalized and postmodern world of the 21st century in its ecclesiological, ecumenical and multicultural context. Then it seeks to ask the relevant pastoral questions looking to the future.

Feminist and Gender Studies course. *Women's authority. Beyond the Gospels in the writings of early Christianity***B1,2,3/M1,2_2 ECTS****(20 hrs total)**

We will read apocryphal writings about women and writings in which women appear as authors. We will follow the traces of women's discipleship, traditions that draw on the figures of Eve, Mary of Nazareth, and the apostolic figure of Mary of Magdala. The struggle for women's authority also passes through revelation and prophecy, as with Thecla, Perpetua, Maximilla and Quintilla, and several others. The very distinction between canonical and apocryphal texts reproduces and perpetuates the marginalization of women enacted in the first centuries of Christianity.
