





#### FIRST SEMESTER

# XATB01 Introduction to the Old Testament/B1\_7 ECTS (5 hours per week)

The course, including the reading of most of the books of the Old Testament, aims to provide - in view of the subsequent phases of the study (exegesis, theology) - essential information on the following topics: content, literary characteristics, structure and composition of the various books; literary history of the Hebrew Bible ; history of Israel and its religion; main theological themes.

# XATCA2, XATCA3, XATCA4, XATCA5 Course. Old Testament Exegesis. The book of Qohelet or Ecclesiastes /B2, 3\_4 ECTS/M1,2\_6 ECTS (2 hours per week)

What is the message of Qohelet, certainly a singular voice within the Hebrew Bible? Was he a sceptic? Or, despite everything, an optimist? Are we dealing with Israel's first philosopher? How does his discourse fit into the Bible? The course proposes the integral reading of the entire book. The analysis of the Hebrew text will be carried out in the weekly Hebrew II class, the commentary will be presented in the late afternoon to facilitate external access.

# Seminar (+ course). Old Testament Exegesis. *The Song of Songs and its interpretations /* M1,2 (additional compulsory hours for specialization) (2hours fortnightly)

What does this collection of (erotic) love songs mean within the Bible? An important element of the discourse on creation? Allegory of the relationship between God and Israel (and the church)? The seminar intends to deal with the Song of Songs both from the point of view of the historical-critical approach and by tracing the history of its interpretations, both Jewish and Christian.

# XATA02 Hebrew II/ B2\_ 3 ECTS (I and II SEMESTER) (1 hour per week)

The translation of texts from the Hebrew Bible of increasing difficulty, prepared by the participants, will be the starting point for exploring textual, grammatical, philological and exegetical aspects. In the first semester the book of Qohelet will be read in its entirety. In the second semester, texts chosen with the participants will be examined.

# **SECOND SEMESTER**

### XATD02, XATD03, XATD04, XATD05 Course. Old Testament Theology. *The notion of covenant (b<sup>e</sup>rît)*/ B2,3\_3 ECTS /M1/M2\_5 ECTS (2 hours per week)

The concept of "covenant" (b<sup>e</sup>rît) is certainly one of the pregnant categories with which the Hebrew Bible interprets the relationship between God, humanity and Israel, emphasizing at times the dimension of promise and gift, and at others that of the bond that it implies for Israel. It is enough to think of the structure of Deuteronomy, inspired by the neo-Assyrian treaties of vassalage, and the sequence Noah (Gen 9), Abraham (Gen 15 and 17) and Israel (Ex 19-24). It is also a theme that links the two Testaments, which has received polemical reinterpretations in the opposition between the church and Israel, and has been taken up in the theological and political reflection of modernity. Without ignoring this history of repercussions, the course will focus on the analysis of the concept of b<sup>e</sup>rît in the Hebrew Bible.

Alongside the synoptic tradition, the Johannine tradition represents a strand of the transmission of the heritage of Jesus of Nazareth that, starting from his Resurrection, lives in the discipleship community through his Spirit. A language, a theological vision, a community experience to express faith in the Risen One in a changing world.

This course will deal with the second part of John's Gospel (from the Last Supper to the Resurrection accounts) through a hermeneutical approach that takes into account philological, historical, social, anthropological and theological aspects.

The course functions as a prepared and careful reading of selected texts in the various literary genres of the New Testament, with special attention to syntax, vocabulary, and construction of discourse or narrative. The course also functions as an introduction to exegesis.

# **SECOND SEMESTER**

XNTB01 Introduction to New Testament Reading/ B1\_7 ECTS (5 hours per week)



The Introduction to the New Testament course is structured around three main topics. First, we delve into the study of the world in which Jesus and the apostles worked. We will deal with the main writings of this rich historical period, which are definitely inescapable if we want to fully understand the origin of Christianity and its theology. The second topic will be the narrative literature of the New Testament: we will study in depth the history of the formation of the texts, the historical and cultural contexts in which they were produced and handed down, the sources, the traditions, the forms, the editing, the relation to historical facts, and the meaning of the story in its narrative development. The study will be illustrated by the reading of various New Testament texts. In addition, issues of New Testament text transmission, canon formation, and translations will be addressed. The third part deals with epistolary literature. It will examine the letters found in the New Testament with particular attention to the Pauline corpus: content and organization of the writings, circumstances and historical context of production, communicative situation, literary composition, theological perspective, particular debates.

Accreditation B1: written and oral examination on the subject of the Introduction course.

# Theology of the New Testament. *The gospel of John in the history of exegesis*/ B2,3\_ 3 EC-TS/M1,2\_5 ECTS

#### (2 hours per week)

The first commentary on the gospel of John was the work of the Gnostic teacher Heracleon, and this already tells us much about the distinctiveness of the fourth gospel within the New Testament. Born perhaps to interrelate with the synoptic tradition, this first interpreter of the gospel was in turn the object of the most varied exegesis and its very distinct characteristics have also made necessary numerous attempts at normalization. Even from the historical and literary point of view he remains an enigma: R. Kysar has called him the "untamable" gospel and, in fact, John retains his own special place on the scene of New Testament exegesis. This course proposes to reflect on the theology of John through the eyes of some of the leading exegetes of Christendom.

#### Accreditation

B2: a) active participation in the course; b) final oral interview on course topics.

B3: active participation in the course; study of a textbook of New Testament Theology; final written and oral examination on the textbook and the topic of the monograph course (examination bibliography given in class)

# HISTORY OF CHRISTIANITY/Prof. Lothar Vogel

#### **FIRST SEMESTER**

# XSCC01, XSCC02, XSCC03 [6 ECTS together with second semester's course] XSCC11, XSCC12, XSCC13 [3 ECTS] Course. History of Christianity in the Epoch of Reformation (1400-1650)/B1,2,3 (2 hours per week)

This course of lectures introduces to the history of the Reformation (from the beginning of the 15<sup>th</sup> century until the end of the Thirty Years' War), giving an overview of Western Christianity in this period, which established the basic terms of the existing 'historic' churches. The perspective of the course will be essentially North Atlantic, taking into account the Protestant churches and Roman Catholicism, but the developments in the Orthodox sphere will also be presented.

#### Accreditation

Accreditation is based on regular attendance and the passing of an oral or written examination. For students who also attend the second semester course of lectures, there is a joint accreditation on the basis of an examination covering the subjects of both courses.

### XSCF02, XSCF03, XSCF04, XSCF05 [6 ECTS together with second semester's course] XSCF12, XSCF13, XSCF14, XSCF15 [3 ECTS] Seminar. *Between "Italian Reformation" and "Reformation in Italy"/*B2,3/ M1,2 (2 hours per week)

In 16<sup>th</sup> century Italy there was a great variety of currents that wanted to reform the church. The analysis of the characteristics of these currents, their links with the Protestant Reformation (or independence from it) and the interests that influenced the history of research on this phenomenon will be the issues of this seminar course.

#### Accreditation

In addition to regular attendance, an oral examination or a seminar paper is required (if the student attends seminars in both semesters, accreditation is joint and takes place on the basis of one paper in the academic year).

#### SECOND SEMESTER

XSCC01, XSCC02, XSCC03 [6 ECTS together with second semester's course] XSCC21, XSCC22, XSCC23 [3 ECTS] Course. Christianity in the 17<sup>th</sup>-18<sup>th</sup> centuries/ B1,2,3 (2 hours per week)

This course of lectures will introduce into the history of Christianity in the period from the 16<sup>th</sup> century's "confessionalization" until the eve of the revolutions at the end of the 18<sup>th</sup> century. The perspective will be focussed on the Western and Northern Atlantic Christianity, considering in particular the Protestant and the Roman Catholic sphere, but the Orthodox sphere and the global mission activities will be considered, too.

This seminar works on the historical sources relating to the 16<sup>th</sup> century Anabaptism. The roots of the movement will be addressed: the abstention from infant baptism in "enthusiastic" circles, the first baptisms of adults in 1525, and the initial plurality of the movement; afterwards also the "Anabaptist kingdom" of Münster, the formation of the Mennonite Church and the Anabaptist component of the "Reformation in Italy" will be treated. The work on the sources will be accompanied by attention to the history of research, which is very complex in this context.

# Inytoduction to Systematic Theology: Basic Structures of Christian Doctrine/B1,2\_3 ECTS (2 hours per week)

The lectures will sketch the main lines of the Christian Doctrine, following the Nicene – Costantinopolitan Creed. The cours has also the methodological goal ti make students familiar with the way of thinking of Protestant Dogmatic Theology.

#### Accreditation

Accreditation requires successful completion of an oral interview, lasting approximately 30 minutes. The first topic of discussion is of the candidate's choice, the second of the instructor's choice. In the optimal case, two topics should suffice. The notes will constitute an element of integration, but obviously do not replace the analytical reading of the texts. Introductions to Luther's texts are part of the required preparation.

Oral interview of about 30 minutes, structured in principle on two topics, the first of which is chosen by the candidate.

# History of religions. Non-Christian religions in Italy. History, doctrine, actuality/ B1,2\_3 ECTS (2 hours per week)

Religious pluralism in Italy is a fact; however, it is not only a recent phenomenon. The presence of Jewish and Islamic communities on Italian territory has a long history. Starting from these two centuries-old presences, the course deals with two other constantly growing religious areas: religions of the Indian subcontinent and those of the Far East (China and Japan). The starting point is the religions in their current state; it is therefore a synchronic approach combined with a diachronic one as far as the history of each single faith community is concerned. The participation of guest lecturers from some of the faith communities analyzed is foreseen.

#### Accreditation

a) Written report (8 000-10 000 characters, including spaces), on a topic agreed upon with the teacher. b) Interview of about 30 minutes, divided, in principle, into two topics, one of which will be chosen by the candidate.

# Prof. Pawel Gajewski XSIJ03, XSIJ04, XSIJ05 Theology of Religions. From faith to faith (Romans 1:17) / B3/M1,2\_3 ECTS (2 hours per week)

The main objective of the course is to identify in the field of Christian theology useful methodological tools for the proper setting of dialogues with other faith communities. An in-depth reflection on the dialectical tension between faith and religion constitutes the conceptual basis of the reflection. The main topics developed during the lessons compose a useful framework for a theological evaluation of the main world religions. The course is completed by a seminar (8 hours) dedicated to the reading of selected texts from Justin the Martyr, The Dialogue with Tryphon (the text will be provided by the teacher).

#### Accreditation

a) Classroom report (about 20 min.) on one of the topics of the seminar part, delivered in written form (10.000-12 00 characters, spaces included), on a subject agreed upon with the teacher.
 b) Colloquium of about 30 minutes, articulated, in principle, on two topics, one of them chosen by the candidate.

# **FIRST SEMESTER**

Lawyer Ilaria Valenzi XTPBD1, XTPBD2, XTPBD3, XTPBD04, XTPBD05 Church Law. Law and Religions/ B1,2,3,\*\*/M1,2\_ 3 ECTS (2 hours per week)

This course will focus on the main issues related to the relationship between the legal sciences and the religious factor, beginning with an investigation of the system of state-faith relations and the impact of old and new pluralism on the right to religious freedom. It will also examine the essential elements of the legal systems of Protestant churches and hints of comparative law of religions (Judaism, Islam). The course will close with a look at the new frontiers of the discipline of the religious phenomenon in some sensitive areas (gender, migration, new technologies) with a focus on the geopolitical dimension of religions.

#### Accreditation

(Re)active participation: a) internal regulations: from the text to the practical implementation (simulations and group work), b) analysis of case studies taken from judgments or emblematic cases provided during the course (pp. 4), c) oral exam on the texts indicated in the bibliography (parts of the texts indicated during the course; material provided during the course)

# Past. Hiltrud Stahlberger-Vogel XTPD01, XTPD02 Catechetics. *"I get on with you": concepts of Transactional Analysis in the catechesis/* B1,2\_3 ECTS (2 hours per week)

The course introduces humanistic concepts, particularly from the Transactional Analysis, which facilitate educational and catechetical processes. Based on a comparison between Protestant anthropology and Transactional Analysis, the course is structured around 6 central themes: communication processes, psychosocial and religious development, the relationship between catechists and catechumens, motivation, the intercultural educational relationship and the promotion of autonomy in faith. Catechesis is understood as a teaching process and as exchange on religious matters with groups of all ages.

#### Accreditation

Active participation, including active experimentation of the concepts learned, and a final oral exam.

Following an historical and analytical introduction and the textual exam of current liturgies, "The service in the making" will propose a "still image" on the evolutions and possible developments of the contemporary protestantevangelical liturgical experience in the Italian and European context, assorted with a few video incursions in North America. Among the main subjects, the implications of televisual-liturgy, bound to last well after the pandemic crisis. Markers and symptoms of the liturgical estrangement will be analyzed, as well as possible antidotes.

#### Accreditation

Re-active participation; a) analytical and descriptive essay on one chapter from *Il culto cristiano* or from *Liturgia come gioco*, completed by a personal contribution (15000 signs); b) drafting of a liturgical sequence, with analysis of choices and implications (15000 signs); Oral exam on the entire course.

Re-active participation; a) presentation in a seminar (30 minutes) of one or more books agreed upon by the professor, with written synthesis (5000 signs) or essay (7000 signs) on the ecclesiological implications in Buber; b) presentation (15000 signs) of a real communication difficulty in a community: parameters, analysis, outcomes; c) Oral exam on the entire course.
